IMPLEMENTATION OF STANDARD OPERATING PROCEDURES
(VERSION 3.0) FOR INTERNATIONAL PASSENGER / CHARTERED /
PRIVATE AIRCRAFT FLIGHTS

Reference our letter of even number dated December 31, 2020 on the above subject containing Standard Operating Procedures (Version 3.0) for International Passenger, Chartered and Private Aircraft Flights Inbound to Pakistan and our letter of even number dated March 20, 2021 enclosing therewith revised Country List for inbound travel to Pakistan.

2. As conveyed by NCOC, this is to clarify that effective **March 23, 2021, 0001 hours upto April 05, 2021**, there will be a complete travel ban on inbound travel to Pakistan from Category C Countries including withdrawal of exemptions earlier provided to Pakistani Passport Holders, NICOP Holders and POC Holders. This temporary measure is being introduced in continuation to the steps being taken to curb the spread of COVID-19 in Pakistan.
3. All concerned are directed to ensure strict compliance.
